ADC'S CULTURALLY-COMPETENT BUSINESS DEVELOPMENT SERVICES AND ITS PARTNERSHIPS WITH CRUCIAL FUNDING SOURCES HAVE DIRECTLY CONTRIBUTED TO THE SURGE IN AFRICAN-OWNED BUSINESSES IN MINNEAPOLIS AND ST. PAUL. IN ADDITION TO ONGOING TECHNICAL ASSISTANCE, ADC OFFERS SIX START-UP BUSINESS WORKSHOPS EACH YEAR. AFTER COMPLETION OF THE WORKSHOP, EACH CLIENT ENGAGES IN TEN HOURS OF ONE-ON-ONE TRAINING WITH ADC'S BUSINESS LENDERS.
